Mission Statement

It is the mission of Jacobsen High School to provide our students, as adjudicated youth at China Springs Youth Camp, a meaningful and useful educational experience that creates and inspires academic achievement, confidence, discipline and physical wellness. Students will be prepared for a successful transition back to their homes, schools, careers, and communities.

Principal's Highlights

JHS serves up to 60 students of varying needs, ability and grade levels in the same classroom at the same time. Though a challenge, our students' success is a reflection of the following highlights:

- Small dedicated staff
- Curriculum aligned with NVACS
- Credit recovery and acceleration
- Transition workshops for successful re-entry

Goals and Objectives

Goal 1

Student will learn meaningful and transferable credits towards back to their home school or towards graduation.

Objective(s):

- Students who enter JHS within four credits of the requirements for graduation, will graduate prior to release from China Spring Youth Camp.
- Students will leave JHS with credits that are a true reflection of core curriculum based on current state standards for specific content areas.

Goal 2

Students will improve academic achievement through the implementation of a curricular delivery program for all content areas that is meaningful, transferrable and aligned to NVACS.

Objective(s):

- Students, using the A+ Online Learning System with consistent teacher instruction and support, will earn 70% or better on final exams and for overall course grade.
- Students will gain at least one academic year as recorded by MAP testing within their four to six month stay at China Spring Youth Camp.

Goal 3

Students will participate in a "Transition with Success" workshop, designed and taught by a JHS teacher, to develop strategies and skills to facilitate a successful re-entry to schools of origin.

Objective(s):

- Students will participate in up to six sessions of a transition workshop, at least three weeks prior to release from China Springs Youth Camp.
- Students will create a resume.
- Students will create goals for "first day back" at school of origin.

- Students will take a multiple intelligence test and career inventory to determine strengths that will foster success.

School Communication Efforts

When students transition from Jacobsen High School to their neighborhood schools, parents are given students' unofficial transcripts, assessment data, and contact persons so that the transition for each student is seamless.
