Mission Statement

Pau-Wa-Lu Middle School is committed to the academic growth of its students, resulting in successful learners, by providing appropriate educational opportunities through course offerings in basic skills, electives, and enrichment areas.

Principal's Highlights

Pau Wa Lu Middle School is a great place for students to learn and grow. As a school, we promote excellence and accountability for all students and staff. We are proud of the following highlights:

- Students are challenged outside the classroom by participating in the geography bee, spelling bee, and Math Olympiads.
- We have implemented technology programs such as Tynker which provides our students exposure to computer coding.
- The Striving Readers Comprehensive Literacy grant continues to provide Read 180 software, an academic and literacy coach, and library supplies.
- 350 students are participating in the Panther Pride program; an incentive program which rewards students for academic and personal excellence.
- The Connections Program, which involves a retreat, monthly activities and mentoring, helps at-risk student feel connected to the school and staff.
- Students are provided academic tutoring two times per week after school and 80 minutes of support each week to assist with homework completion.
- Our Academic Success and Enrichment programs offer students extra challenges.

Goals and Objectives

Goal 1

As a school, students will demonstrate proficiency at or above grade level in the area of math by implementing the Nevada Academic Content Standards (NVACS).

Objective(s):

1. Increase percentage of students scoring "Meets Standards" or Exceeds Standards" from 52.4% to 70% in SBAC math assessment.
2. Increase MGP in math from 60.5% to 61%.
3. Increase AGP in math from 37.4% to 53%.
4. Increase AGP of IEP, LEP & FRL students in math from 28.4% to 42%.
5. All students will make a minimum of 1 years growth on the math MAP assessment.

Goal 2

As a school all students will demonstrate proficiency at or above grade level in the area of reading by implementing the Nevada Academic Content Standards (NVACS).

Objective(s):

1. Increase percentage of students scoring "Meets Standards" or Exceeds Standards" on the SBAC reading assessment.
2. Increase MGP in reading from 48% to 60%.
3. Increase AGP in reading from 64.1 to 70%.
4. Increase AGP of IEP, LEP & FRL students in reading from 52.5% to 58%.
5. All students will make a minimum of 1 years growth on reading MAP assessment.

School Communication Efforts

We believe parent communication is essential to student achievement. We hosted the Parent Expo; an event which allowed parents to select workshops geared towards being parents of middle school students. We utilize multiple tools to insure parents receive information from Pau Wa Lu. Our year starts with hosting a 7th grade Parent Orientation and Back to School night for all our students and their parents. All 8th graders participate in a meeting with their parents and counselor to develop an education plan. The PWL website is kept up to date with school events and important information. We have established a social media presence through the use of Facebook and Twitter. The website also provides accessibility to teachers via email. PWL publishes a monthly newsletter and utilizes our auto-dialer phone system to disseminate information on upcoming events and important reminders. To communicate academic progress, grades are available online and progress reports are also sent home every 6 weeks. A computer kiosk is available in the main lobby for parents to access their student's grades.
